4. General Provisions

Control over compliance with these regulations during the SEMI FINAL is carried out by the semi-final organizers. Control during the FINAL of the WORLDS Championship is carried out by the final - the Worlds team. The organizer reserves the right to make organizational changes, including replacement of judges, changes in the schedule, or adjustments to the competition format, if necessary for the fair and safe execution of the event.

5. Participants

5.1 All participants must comply with the championship regulations and, by participating, acknowledge their fairness.

5.2 Artists of permanent make-up and microblading of all levels with confirmed certificates who have reached the age of eighteen, regardless of place of residence and citizenship, are allowed to participate.

5.3 Participation fees are non-refundable in case of cancellation, absence, or disqualification.

6. Competition Structure

The number of categories in the semi-final is unlimited. Only first-place winners qualify for the final. A participant may compete in only one category in the final. If a participant wins multiple categories, they must choose one, and the next participant in ranking will take their place. The organizer reserves the right to make the final decision regarding participant selection.

7. Models

Participants are responsible for providing their own models and bear full responsibility for them. The organizer is not responsible for model delays or absence. In case of absence, the participant will be disqualified without the right to a refund.

8. Participant Responsibilities

Participants must comply with hygiene rules, bring their own equipment, arrive on time, and remain in the competition area throughout the event.

9. Competition Rules

Participants are not allowed to leave the competition area or publish any photos or videos of their work before the official announcement of results. Violation of this rule results in immediate disqualification without the right to appeal.

10. Time Limits

SEMI FINAL: 3 hours - total time (2,5 hours work time)

11. Responsibility

Participants bear full responsibility for their model and the results of their work. The organizer is not responsible for the results or any complications.

12. Judging

Judging is anonymous and final. Participants have no right to appeal or dispute the results.

13. Conduct

Participants must behave professionally and respectfully towards organizers, judges, and other participants. Any inappropriate behavior or attempt to influence judging will result in disqualification.

14. Media Consent

Participants agree that photos and videos taken during the event may be used for marketing, promotional, and educational purposes without any financial compensation.

15. Final Statement
